THE FOLLOWING MUST ACCOMPANY THIS FORM:

- Printed picture of the dog you are registering.
- Evidence of the fact that you have posted clearly visible "Dangerous Dog" warning signs.
- Evidence that the dog you are registering has received an annual rabies vaccination in accordance with Chapter 71-10A of the Code of the Town of Elsmere.
- Evidence of the proper Liability Insurance Coverage as required by the code listing the Town of Elsmere as Other Insured.
- Payment of all applicable fee(s).

REQUIREMENTS:

- Owner shall at all times ensure that the dog is securely confined indoors, or confined in an enclosure as defined in Chapter 71 of the Code of the Town of Elsmere. At any time that the dangerous dog is not so confined, the dog shall be muzzled in such a manner as to prevent it from biting or injuring any person or animal, and kept on a leash with the owner or custodian in attendance except for while the dog is being transported within the cab or passenger portion of any motor vehicle, provided said vehicle has a roof, and the dog cannot escape through an open window.
- Owner shall notify the code enforcement officer immediately if a dangerous dog is on the loose, is unconfined, has attacked another animal or has attacked a human being, or has died or has been sold or given away. If the dangerous dog has been sold or given away, the owner or keeper shall also provide to the Code Enforcement Department the name, address and telephone number of the new owner of the dangerous dog.
- Owner shall notify the code enforcement officer of any cancellation, modification, expiration or termination of the applicable liability insurance policy or surety bond.
- A dangerous dog is not required to wear an adult license tag but is required to wear a special dangerous dog license issued by the Town.
- The dangerous dog permit must be renewed annually. Failure to renew the dangerous dog permit within 30 calendar days from the expiration of the previous tag will result in the assessment of a late renewal penalty and will subject the owner or keeper to a citation for noncompliance.
- In the event a current dangerous dog permit is lost, destroyed, or misplaced or otherwise missing, a replacement dangerous dog license tag must be obtained. The current fee for a replacement dangerous dog permit is \$5.00.

I have read and understand the above requirements relating to the registration of a dangerous dog in accordance with Chapter 71 of the Code of the Town of Elsmere and agree to comply with all requirements set forth by applicable ordinances established by the Town of Elsmere and as they may be amended. I agree to allow the Code Enforcement Officer or his/her designee access to the property where my dog is owned, kept or harbored for the purpose of inspection and verifying compliance with the regulations and ordinances pertaining to proper animal care and maintenance.
