# A RESOLUTION SETTING FORTH THE FEES, FINES AND PENALTIES ASSOCIATED WITH CHAPTER 71 OF THE CODE OF THE TOWN OF ELSMERE

**WHEREAS**, Chapter 71 of the Code of Elsmere requires that certain fines, and associated with this chapter fees be set by resolution of the Mayor and Council.

### NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF ELSMERE,

That the following fines and fees are hereby approved by the Mayor and Council as the fines and fees associated with Chapter 71 of the Town of Elsmere.

- 1. In regard to Section 71-7 b of Chapter 71, the Mayor and Council hereby approve the current fees established by the State of Delaware Department of Public Health and any agency they authorize to act on their behalf to provide these services, including any future modification(s) to these fees, which may be approved by the Delaware Department of Public Health.

  (Fees associated with impoundment)
- 2. In regard to Section 71-12 (d) (1) of Chapter 71, the Mayor and Council hereby approve a fee of two hundred and fifty (\$250.00) dollars, as a filing fee for the Hearing Officers.
- 3. In regard to Section 71-12 (g) (2) of Chapter 71, the Mayor and Council hereby approve a fee of one hundred (\$100.00) dollars, for the late registration of a Dangerous Dog.
- 4. In regard to Section 71-12 (g) (2) (a) of Chapter 71, the Mayor and Council hereby approve a fee of fifty (\$50.00) dollars as a registration fee of a Dangerous Dog.
- 5. In regard to Section 71-12 (g) (2) (b) of Chapter 71, the Mayor and Council hereby approve a fee of fifty (\$50.00) dollars, for obtaining a "Dangerous Dog Permit".
- 6. In regard to Section 71-12 (g) (2) (b) of Chapter 71, the Mayor and Council hereby approve a fee of one hundred (\$100.00) dollars, for failing to renew a "Dangerous Dog Permit".

- 7. In regard to Section 71-12 (g) (2) (b) of Chapter 71, the Mayor and Council hereby approve a fee of five (\$5.00) dollars, for a "Replacement Dangerous Dog Permit".
- 8. In regard to Section 71-14 (b) of Chapter 71, the Mayor and Council hereby approve a fee of one hundred (\$100.00) dollars, "late registration penalty for registering a Guard Dog".
- 9. In regard to Section 71-14 (b) (2) of Chapter 71, the Mayor and Council hereby approve a fee of fifty (\$50.00) dollars, for obtaining a "Guard Dog Registration Fee".
- 10. In regard to Section 71-13 (b) (3) of Chapter 71, the Mayor and Council hereby approve a fee of one hundred (\$100.00) dollars, for failing to renew a "Guard Dog Permit".
- 11. In regard to Section 71-14 (b) (3) of Chapter 71, the Mayor and Council hereby approve a fee of one hundred (\$100.00) dollars, for a "Late Renewal Penalty for a Guard Dog Permit".
- 12. In regard to Section 71-14 (b) (3) of Chapter 71, the Mayor and Council hereby approve a fee of five (\$5.00) dollars, for a "Replacement Guard Dog Permit".
- 13. In accordance with Section 71-30 (a) of Chapter 71, the Mayor and Council hereby approve a civil penalty of not less than fifty (\$50.00) dollars nor more than one hundred (\$100.00) dollars, for any person cited for failing to comply with any of the rules or requirements set forth in this chapter, for which a penalty or fee is not specifically noted in this resolution.
- 14. In regard to Section 71-30 (b) of Chapter 71, the Mayor and Council hereby approve a fee of five-hundred (\$500.00) dollars, for committing "Cruelty to Animals".
- 15. In regard to Section 71-30 (c) of Chapter 71, the Mayor and Council hereby approve a fee of fifty (\$50.00) dollars, as a "Delinquency Fee"
