
#### **Significant Events:**

On the following dates/times Elsmere Bureau of Police officers handled the below incidents and seized the following drugs, money and weapons during the month.

#### September, 2016:

### September 5<sup>th</sup>, 2016

Ptlm. Macdowell responded for the report of a burglary in progress in the unit block of Tamarack Avenue. Upon arriving Ptlm. MacDowell made contact with two victims who stated that 38-year-old Kevin Beale from the 2400 block of Darnay Lane and 39 year old Kevin Hayden of the Unit block of Colonial Avenue came to the residence and broke the window. Both suspects took turns climbing halfway through the window and threatening the victims. The suspects fled in a vehicle, which was later stopped by the Delaware State Police, and the suspects were placed into custody. They were both charged with Burglary 2<sup>nd</sup> degree, Criminal mischief and terroristic threatening. Bail was set at \$11000.00 unsecured.

### September 11, 2016.

Pfc. Wingate and Ptlm. MacDowell responded to the unit block of Alvil Road reference to a domestic related cutting. The investigation revealed that 27-year-old Justin Ninivaggi began arguing with his mother's boyfriend after a day of drinking. During the argument, Justin produced a knife and cut the victim on the hand. While placing Justin into custody, his mother Kristin Goytia attempted to intervene and threw a knife at the feet of Ptlm. Wingate. Justin was charged with Assault 2<sup>nd</sup> degree, Possession of a weapon during the commission of a felony and Menacing and bail was set at \$50050.00 unsecured. Kristin was arrested for menacing; Possession of a controlled substance x 2, and Resisting arrest and her bail was set at \$1000.00 unsecured.





## **September 14, 2016.**

Ptlm.Macdowell stopped a vehicle for traffic violations and observed the driver Anthony Matos of the 200 block of North Dupont Street in Wilmington to be extremely nervous, and shaky. While speaking to Anthony Ptlm. Macdowell observed drug paraphernalia on the floor of the vehicle. A further search of the vehicle produced 118 bags of heroin. Anthony Matos was charged with Possession of a controlled substance, possession of drug paraphernalia, and traffic violations his bail was set at \$6,000 secured and he was transferred to the Department of Corrections in lieu of bail.



## **September 18, 2016**

Cpl. Kerrigan stopped a vehicle for speeding violation, while making contact with 18-year-old Domere Robinson from the 1700 block of Barnaby St, Newark DE. Cpl. Kerrigan noticed a strong odor of burnt marijuana coming from the inside of the vehicle. Domere was removed from the vehicle and a 9mm pistol was found in his pocket. Upon further investigation, it was discovered the handgun had an obliterated serial number, and Domere was in possession of a small amount of Marijuana. Domere was charged with Carrying a Concealed Deadly Weapon, Possession of Firearm during the Commission of a Felony, Possession of a Weapon with a Removed, Obliterated or Altered Serial Number, Possession of Marijuana, Driving without a Valid License and Speeding in Excess of Posted Limits. Domere's bail was set at \$15,000 secured.
