A RESOLUTION ADOPTING A MITIGATION ACTION INTO THE MITIGATION PLAN FOR THE TOWN OF ELSMERE

WHEREAS, the Disaster Mitigation Act of 2000, as amended, requires that local governments develop and adopt natural hazard mitigation plans in order to receive certain federal assistance; and

WHEREAS, the Town of Elsmere currently has an approved New Castle County Multi Jurisdictional All Hazard Mitigation Plan and its 2010 update; and

WHEREAS, the New Castle County Multi Jurisdictional All Hazard Mitigation Plan and its 2010 update did not include a mitigation action to Support cost of effective flood proofing of existing structures throughout the Town; and

WHEREAS, the current Hazard Mitigation Assistance Program Guidance requires mitigation actions to be identified in the local mitigation plans.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF ELSMERE,

That the Town of Elsmere Mitigation Actions listed which includes the New Castle County Multi Jurisdictional All Hazard Mitigation Plan and its 2010 update are hereby amended to include the attached Mitigation Action, Identified as Elsmere Mitigation Action 9, to Support cost effective flood proofing projects throughout the Town.
