# ELSMERE POLICE DEPARTMENT Monthly Report September 2016

## **Significant Events:**

On the following dates/times Elsmere Bureau of Police officers handled the below incidents and seized the following drugs, money and weapons during the month.

## August 16, 2016:

#### Heroin Arrest:

On August 16, 2016, Cpl. Kevin Kerrigan and PFC Steven West were dispatched to the 1200 block of Sycamore Avenue for a domestic assault. While responding to the scene officers learned that the suspect, 29-year-old Marshall Childress of the 1200 block of Sycamore Avenue fled the residence and was walking on foot in the area. Cpl. Kerrigan observed Marshall, at which point he fled on foot and was observed reaching into his pocket. When Marshall was apprehended a sock that contained 95 bags of heroin and 1.9 grams of marijuana was found near him. Marshall was also in possession of \$2,110.000 in US Currency that was seized after a police K9 alerted on the suspected drug proceeds. Marshall was charged with Possession of Heroin, Possession of Marijuana, Offensive Touching and Resisting Arrest. Marshall's bail was set at \$4,100.00 unsecured and he was committed to the Howard Young Correctional Facility in lieu of \$430.00 cash bail for several outstanding capiases.





# **August 18, 2016:**

Heroin/Marijuana Arrest:

On August 18, 2016, Ptlm. Kevin MacDowell observed suspicious behavior in the area of the McDonalds in Elsmere. As Ptlm. MacDowell investigated further, he made contact with 24-year-old Clarence Rivera of the 1900 block of Seneca Road. During the encounter, Clarence fled on foot and was observed throwing something to the ground before he was apprehended. Inside of the package, Clarence discarded were 52 bags of heroin and 3.7 grams of marijuana. Clarence was charged with Resisting Arrest and Possession of Heroin and Marijuana. Bail was set at \$1,500.00 unsecured. Clarence was committed to the Howard Young Correctional Facility as a result of his arrest, which violated his probation.



## August 18, 2016:

On Thursday August 18, 2016 at 11:00 p.m., Cpl. Andrew Davis responded to the area of the USA Gas located at 615 Kirkwood Highway for the report of an assault. Upon arriving, Cpl. Davis made contact with a citizen who witnessed the incident and stepped into to stop the assault. The victim was identified as a 16 year old female who was reported as a run-a-way from West Virginia. The suspect was later taken into custody with help from the New Castle County Police and was identified as the victim's boyfriend, 26-year-old Shawn Bradley from Fairmont, WV. Def. Bradley was charged with Assault 3<sup>rd</sup> and was committed to the Howard Young Correctional Facility in lieu of \$5000.00 cash bail.

# **August 19, 2016:**

Narcan Save:

On August 19, 2016, PFC West responded to Unit Block of Ashley Place to assist NCCPD with a heroin overdose. PFC West and Cpl. Mitchell were first on scene with Five Points EMS right behind them. Officers located an unresponsive male inside the residence. Officers administer two doses of Narcan, which revived him. Five Points transported the male victim to the hospital for medical evaluation.

# August 31, 2016:

Assault Arrest:

On August 31, 2016, PFC Wingate responded to the Unit Block of Ruth Road for an assault that just occurred. Upon arrival, Cpl. Kerrigan and PFC Wingate made contact with two victims. One victim sustained a severe laceration to his left hand and second victim was struck in the head with a beer bottle.

Upon further investigation officers arrested Lamont Nock of 200 Block of Bungalow Avenue for Assault 1st, Assault 3rd, and Possession of a Deadly Weapon During Commission of a Felony. He was then issued \$40,500.00 secured bail and was transported to Howard Young Facility after failing to post bail.
