Status report from Mr. McNally

Mr. McNally gave a status update regarding the property at 203 Bungalow Avenue and stated that a hearing has been scheduled on August 23, 2018 in which the judge has requested the parties responsible for the property should be present. Mr. McNally stated that the receivership of this first property establishes a precedent. Mr. McNally noted that the mortgage holder has not made contact with the town in seven months despite numerous attempts from the Town.

Chairman Jaremchuk redirected the discussion back to the property at 505 Junction Street after the directors had an opportunity to review the information packet that was passed around. The directors continued to discuss the condition of the property and whether to take the property to receivership.

Mr. McNally reminded the directors that once the judge approves the receivership of 203 Bungalow Avenue then the property becomes their responsibility and they have to be ready to keep good records.
