#### **ORDINANCE 652**

# AN ORDINANCE TO ADOPT TITLE 21 OF THE DELAWARE CODE, AS AMENDED, RELATING TO THE OPERATION OF MOTOR VEHICLES, FOR APPLICATION WITH THE BOUNDARIES OF THE TOWN OF ELSMERE.

**WHEREAS,** The Mayor and Council of the Town of Elsmere desire to provide its citizens with the assurance of safety upon the municipal highways within the boundaries of the Town of Elsmere; and

**WHEREAS**, the State of Delaware has enacted Title 21 relating to the operation of motor vehicles;

## NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF ELSMERE, AS FOLLOWS:

- 1. Title 21 of the Delaware Code as amended, has been adopted as the law within the Boundaries of Elsmere and all sections of Title 21.
- 2. The Elsmere Traffic Code shall include all offenses and language currently or subsequently included in Title 21 of the Delaware Code, with the exception of penalties for offenses, which are defined in Table 3 B of this Ordinance.
- 3. Penalties for specific offenses defined in the Elsmere Traffic Code (Title 35) shall be established in Table 3 B, attached here to, and incorporated herewith.
- 4. This ordinance shall not usurp for or convey upon the Mayor and Council any responsibilities or duties which, under Title 21 of the Delaware Code are the exclusive jurisdiction of the State of Delaware.
- 5. All ordinances or sections thereof inconsistent with the provisions of this ordinance are hereby repealed and/or amended to the extent of the inconsistency.
- 6. If any part of this Ordinance or Title 21 of the Delaware Code shall be held invalid, such part shall be deemed severable, and the invalidity thereof, shall be deemed severable, and the invalidity thereof, shall not affect the remaining parts of this Ordinance or Title 21 of the Delaware Code.
- 7. Other Ordinances or parts of other ordinances deemed to be in conflict with this Ordinance are hereby repealed and super ceded to the extent that other such Ordinances or parts of Ordinances are in conflict, provided that such repeal shall not abate a right of action already accrued under any repealed Ordinance.

8. The Town Secretary shall certify to the adoption of this Ordinance and this Ordinance shall take full force and effect immediately after the date of final passage and approval.
